GRHC Takes Action to Help Residents Cope with Rising Rents

In March the U.S. Department of Housing and Urban Development (HUD) published updated Fair Market Rents (FMRs) for Kent County and the Grand Rapids-Wyoming Metropolitan Area, increasing the maximum allowable rent for all unit sizes by nine percent; the FMRs set by HUD annually establish a rent ceiling for HUD rental subsidy programs, including the Housing Choice Voucher program that serves thousands of lowincome households in our area.

HUD revised the FMRs after the Grand Rapids Housing Commission (GRHC) provided the agency with the results of a Fair Market Rent Survey our staff conducted with the help of a contracted research firm. The survey was distributed to 25,000 Kent County households and demonstrated that while the original local 2023 FMRs set by HUD increased 17 percent from 2022, they still fell short of actual local rents.

The updated HUD FMRs will not only benefit Grand Rapids Housing Commission program

participants but also households that participate in HUD-funded programs administered by various agencies in Kent County, including HOME Investment Partnership developments, the Emergency Solutions Grant program and Continuum of Care Fund recipients.

"Our board and staff are sincerely grateful to the 1,560 households that responded to our recent FMR Survey," said GRHC Executive Director Lindsey S. Reames. "Their participation has made an important and tangible difference for GRHC program participants and for all of the assisted families in our area that struggle to attain a basic need many of us take for granted—decent, affordable housing for ourselves and our families."

The GRHC continues to analyze local market conditions and recently amended the maximum rents for our voucher programs to 115 percent of the HUD FMRs. Current GRHC Voucher Payment Standards can be viewed at www.grhousing.org.

GRHC Expands Project-Based Voucher Support of Affordable Housing Developments

The Housing Commission recently awarded or committed 67 Section 8 Project-Based Vouchers (PBVs) to local affordable housing developers as part of a strategy designed to increase the availability of affordable housing in our community; this brings the total number of partner units supported by the GRHC to 262. A component of the federal Housing Choice Voucher rental subsidy program, PBVs provide a monthly rental subsidy for low-income households, with rent typically 30 percent of adjusted monthly household income. A PBV award provides a significant advantage to developers seeking federal Low-Income Housing Tax Credits.

The developments that received Project-Based Voucher awards:

 Academy Manor, 6 vouchers, 2025 Fulton Street East; owner/ manager: PK Companies. The project will split the five-story Dominican Sisters Mother House building on the Marywood Campus into condominiums that will include 108 senior units.



Kingsbury Place Apartments is a 44-unit Dwelling Place development that serves individuals with mental and physical disabilities

- Belknap Place Apartments, 4 vouchers, 310 Trowbridge Street NE; PK Companies and Third Coast Development. Awarded Low-Income Housing Tax Credits, this 50-unit apartment building is in the historic Belknap Lookout neighborhood.
- First Hope at 10th Apartments, 11 vouchers, 91 and 100
 - West 10th Street, Holland. This Dwelling Place property will feature 46 one- and two-bedroom units for very low-income families. Construction starts in February 2024, with occupancy in December 2025.
 - Kingsbury Place Apartments, 11 vouchers, 730 North Center Court NW; owned by Genesis Non-Profit Housing Corp. and managed by Dwelling Place. Includes 44 units and outdoor green space. A collaboration with Pine Rest Christian Services provides on-site supportive services to residents with mental and physical disabilities.
 - Leonard Avenue Apartments, 13
 vouchers, 851 Leonard Street NW. In
 development, the 55-unit property is
 owned by Genesis Non-Profit Housing
 Corp. and will be managed by Dwelling
 Place. Will serve ages 55 and older and
 have a preference for Native Americans.
 - Shea Ravines, 20 vouchers, 2929
 Burlingame Avenue SW, Wyoming; co-owned/co-developed by WODA
 Cooper Development Inc. and Cherry Health. One- and two-bedroom units will serve people with disabilities.
 Anticipated opening in 2025.
 - Well House Rising, 2 vouchers, various southeast-side locations. Well House is a not-for-profit corporation that develops and rehabs units to provide permanent, shared, low-cost housing for families experiencing homelessness.

City Awards \$500,000 Grant in Support of Renovation



Constructed in 1990 with donated labor and materials, the Hope Community Service Center includes 12 housing units as well as management offices and resident meeting space. The program serves families experiencing homelessness and also includes 12 duplex units.

The City of Grand Rapids has awarded the GRHC a \$500,000 grant in support of our plan to undertake extensive renovations at Hope Community, a 24-unit Rapid Re-Housing program facility that was constructed in 1990. The funds are made available through the City's Fiscal Year 2024 Neighborhood Investment Plan, HOME-American Rescue Plan (HOME-ARP) Allocation Plan, and Economic Resiliency and Recovery Investment Strategy (ERRIS).

The GRHC has identified \$2.4 million in capital needs at Hope Community, so this grant represents a partial but very significant step toward making much-needed repairs and improvements. Staff are in the process of prioritizing renovations that will get underway this summer—watch for details in a future edition of this newsletter.

With the goal of encouraging families to take advantage of a tool they can use to build personal financial well being, the GRHC has developed a short video introduction to our Family Self-Sufficiency (FSS) Program. The video highlights the benefits of participation in the HUD-funded program, which offers GRHC clients an opportunity to accrue funds in an escrow account when an increase in earned income increases the portion of monthly rent a household pays. FSS Program participants receive the escrowed funds upon graduation from the program.

Winners must maintain a minimum 2.5 GPA and fulltime enrollment to receive \$500 annually for up to four years; the total potential scholarship award is \$2,000.

The Jean McKee Resident Scholarship Program is funded through private donations, and we thank our generous donors for making it possible to distribute \$43,000 to 41 scholarship winners over the years.

The Jean McKee Resident Scholarship Program also offers YMCA Summer Camp Scholarships to young residents of the GRHC's family housing developments—watch for details of this year's Summer Camp program in the fall edition of this newsletter.
