The Grand Rapids Housing Commission (GRHC) governing board recently approved an expansion of the GRHC's service area; beginning spring 2023, our agency will serve not only Kent County but also Ottawa County, including the cities of:

Allendale Lamont
Conklin Macatawa
Coopersville Marne
Ferrysburg Nunica
Grand Haven Spring Lake
Holland West Olive
Hudsonville Zeeland
Jenison

This change is the result of several factors:

- A severe rental housing shortage in Greater Grand Rapids has created an extremely competitive rental market; over the past year only about 35 percent of our Housing Choice Voucher (HCV) program clients have been successful in their search for an affordable unit. Expanding our service area expands the pool of available units.
- The Ottawa County Housing Commission does not have HUD funding or authorization to operate an HCV program. The U.S. Department



• The GRHC is committed to partnering with HUD, the Michigan State Housing Development Authority (MSHDA), local governments and area developers to expand the availability of affordable housing in West Michigan. The service area expansion makes it possible for the GRHC to commit Project-Based Vouchers in support of Ottawa County developers who are pursuing federal tax credits to build affordable housing.

"The service area expansion recognizes the prevalence of commuting between counties for employment as well as the fact that some rental properties overlap county lines," noted GRHC Executive Director Lindsey S. Reames. "We look forward to serving Ottawa County residents and also to introducing many new landlords and developers to the benefits of supporting low-income households through participation in the Housing Choice or Project-Based Voucher program."



## **GRHC** to Participate in new HUD Initiative Focused on Helping Households Build Assets

The GRHC is one of 18 public housing authorities nationwide selected to participate in a HUD "Moving to Work" (MTW) Demonstration Program cohort that will help assisted households create and grow personal savings. First authorized by Congress in 1996, MTW gives housing authorities the flexibility to try "outside the box" ideas that address community needs in innovative ways.

Launching during fall 2023, the planned Asset Building initiative will invite a limited number of randomly selected GRHC Housing Choice Voucher (HCV) program participants to open a personal savings account into which the Housing Commission will make regular monthly deposits and even match a portion of the participant's own deposits over a period of two years. The initiative will include a youth component that invites teen children of each participant to open savings accounts, with the GRHC making small monthly deposits and partial matching deposits to help youth experience the benefits of building savings.

The GRHC's financial commitment is estimated at \$100,000; staff is seeking funding from financial institutions,



private donors and foundations. We will also have the option to use funds from HCV Housing Assistance Payments reserves as well as HUD Operating Fund and Capital Fund program grants to finance the initiative.

"The Housing Commission is designing a sustainable program that increases the number of assisted households that have savings accounts and will also help these families build credit worthiness," said GRHC Executive Director Lindsey S. Reames. "The goal is to help households attain housing stability and a stronger financial future for both themselves and their children."

Reames noted that the GRHC's participation in the MTW Demonstration Program will support housing access and equity in ways that extend beyond the Asset Building initiative because of the administrative flexibility the program affords. She said the agency is implementing or considering a number of activities designed to help low-income families find housing in our tight rental market, including:

- Incentivizing landlords to participate in the HCV program.
- Encouraging new affordable developments by increasing the number of Section 8 Project-Based Voucher (PBV) units the GRHC supports. The GRHC recently invited affordable housing developers to apply to receive PBVs for rehabilitation or new housing projects.
- Establishing Fair Market Rent payment standards that accurately reflect the rental market.

## **Public Hearing on 2023 Agency Plan, MTW Supplement**

The Grand Rapids Housing Commission has developed its 2023 Annual Agency Plan and 2023 Moving to Work (MTW) Supplement in compliance with applicable HUD regulations. Moving to Work is a demonstration program that allows housing authorities to design and test innovative strategies for providing low-income families with affordable housing and paths to economic independence.

The GRHC will hold a public hearing regarding its 2023 Annual Agency Plan and 2023 MTW Supplement on Monday, March 13, at 6:00 p.m. in the Campau Commons Community Center located at 821 Division Ave. South. The meeting will also be accessible online and via phone.

## **Housing Commission Introduces New Landlord Incentive Program**

The GRHC hosted a "Landlord Forum" in early November, rolling out a Landlord Incentive program that offers rental property owners and managers the opportunity to earn up to \$1,500 in cash when they rent to a family that participates in our Section 8 Housing Choice Voucher program.

There are two levels of Landlord Incentive program participation:

## New or Returning Landlord\* — \$1,000

One-time payment of \$1,000 to a new landlord who has not participated in the GRHC Housing Choice Voucher program or who left the program in the last 12 months and is now returning. \*Payment received when the Housing Assistance Payments (HAP) contract is signed.

## Participating Landlord\*\* — Up to \$1,500

One-time payment of \$500 to a landlord who currently participates in the GRHC Housing Choice Voucher program and who rents up to three additional units—that's \$500 per additional unit!

\*\*Payment received when the Housing Assistance Payments (HAP) contract is signed; lease renewals are not eligible.

#### **How to Receive the Cash Landlord Incentive**

Landlords who qualify to receive an incentive program payment should request a Landlord Incentive form that's available at the GRHC Administrative Office, 1420 Fuller Avenue SE, or online at www.grhousing.org/pdf/LandlordIncentive.pdf and submit the completed form to GRHC staff along with the Request for Tenancy Approval (RFTA). Staff conduct HUD-required due diligence, and when the landlord submits the Residential Lease and Housing Assistance Payments (HAP) contract and rental assistance begins, we process the appropriate incentive payment.

Please note that the Landlord Incentive program is available for units in Kent and Ottawa counties only. The program may be discontinued when available funding is exhausted.

As of early February, three landlords had received a total of \$2,500 in incentive payments.

## Update on Fair Market Rent (FMR) Survey and 2023 GRHC FMRs

Differences between the maximum "Fair Market Rents" (FMRs) set by HUD annually and the actual cost of rental units in West Michigan have made finding an affordable home extremely challenging for participants in the GRHC's Housing Choice Voucher (HCV) program; only about 35 percent of voucher holders looking for housing were able to find a unit this past year, and that was despite the fact that the GRHC had received a waiver that allowed us to set FMRs at 120 percent of the 2022 HUDestablished FMRs. The waiver expired on December 31, 2022.

As reported in the fall edition of this newsletter, the GRHC has worked with a research firm to conduct a Kent County rent study, with the goal of obtaining data that would support an appeal to HUD for FMRs that more accurately reflect the highly competitive situation in our rental marketplace. Results from this study indicate that the local 2023 FMRs should be 3 to 5 percent higher than those established by HUD using revised methodology that was intended to resolve the issue of FMRs falling way below actual market rents.

With the goal of seeking a more permanent solution to the problem of annual FMRs falling well below actual market rents, the GRHC has provided the Kent County rent study data to




HUD and has received assurances that the agency will analyze our findings and determine whether 2023 FMRs should be adjusted; any increase in FMRs would be finalized in April 2023. To ensure that client households are not at a competitive disadvantage in the meantime, the GRHC has set the FMRs that went into effect January 1 at 110 percent of the HUD-established FMRs—the maximum allowed by HUD.

## 2023 Jean McKee Resident Scholarship Program Offers \$2,000 College Scholarships

The 2023 Jean McKee Resident Scholarship competition is underway! Established in 2000 in memory of longtime Housing Commissioner Jean McKee, the Resident Scholarship program offers college scholarships to eligible residents of GRHC housing programs. Scholarship winners receive \$500 per year for up to four years, for a total scholarship award of up to \$2,000.

# Since the program's inception, the GRHC has awarded scholarships totaling \$43,000, helping 39 residents pursue higher education.

**Eligibility Requirements:** 

- Must have been a resident of a GRHC housing program for the past year.
- Household must be in good standing with the GRHC in accordance with our Housing Choice Voucher Administrative Plan and Admissions & Continued Occupancy Policies.
- Open to graduating high school seniors, current college or vocational school students, and adult residents seeking to begin or return to college or vocational school. Graduating high school seniors, Family Self-Sufficiency Program participants and undergraduate students will receive priority status.
- Graduating high school seniors and those currently attending college must have a cumulative GPA of at least 2.5 (C+ letter grade).

- Applicants seeking to return to college or vocational school must provide an official high school or college transcript which demonstrates that the applicant is a high school graduate and had a cumulative high school or college GPA of at least 2.5.
- Must attend an accredited vocational school, community college, college or university as a full-time student.
- Scholarship winners are eligible to renew the scholarship annually for up to four years. Continuing requirements:
  - Maintain a cumulative 2.5 GPA.
  - Maintain full-time enrollment.

Application Requirements by Applicant Status:

#### ALL APPLICANTS:

- Completed Jean McKee Resident Scholarship Application Form.
- Short essay (300 words) on the topic "My career goals and how the educational program I am pursuing will help me reach these goals."

GRADUATING HIGH SCHOOL SENIORS:

- High school transcript that shows graduation and minimum GPA of 2.5.
- Letter or email of recommendation from a teacher or administrator at the applicant's high school; email recommendation must be from the teacher's school email account. Copy of letter of acceptance from an accredited vocational school, college or university.

CURRENT COLLEGE OR VOCATIONAL SCHOOL STUDENT:

- Letter or email of recommendation from an instructor or counselor at applicant's school; email must be from the instructor's school email account.
- Official school transcript that shows:
  - A cumulative GPA of at least 2.5.
  - Enrolled full-time during the term preceding application.
  - Enrolled full-time for the upcoming fall term.

Adult Seeking to Begin or Return to College:

- Official high school or college transcript which demonstrates that the applicant is a high school graduate and had a cumulative high school or college GPA of at least 2.5.
- Copy of letter of acceptance from an accredited vocational school, college or university.
- Proof of full-time enrollment for the upcoming fall term.

## Huntington Bank Awards \$20,000 Grant in Support of Family Self-Sufficiency Program

Huntington National Bank has awarded the GRHC a \$20,000 grant in support of the Family Self-Sufficiency (FSS) Program that helps GRHC program participants increase financial stability and move toward economic independence and well-being.

The FSS Program is a voluntary initiative that empowers participants to build a financial "nest egg" when an increase in earned income increases the household's share of monthly rent; an amount roughly equal to the rental payment adjustment is deposited into an escrow account to benefit the family each month. Escrow can accrue for up to five years and is disbursed when the participant graduates from the program.

To successfully complete the program, a family must be free of Temporary Assistance for Needy Families (TANF) cash assistance for at least the last 12 months of the FSS contract, the head of household must have income from gainful employment for the last 12 months of the contract and the family must have fulfilled all training and service plans. During 2022 the FSS Program disbursed a total of \$240,973 to

34 program graduates; one graduate used her \$27,000 award to purchase a home!

"The Housing Commission is grateful to Huntington for supporting our efforts to help assisted families work toward self-sufficiency," said GRHC Executive Director Lindsey S. Reames. Reames noted that the Huntington grant funds will be used specifically for activities designed to increase FSS Program

enrollment by an additional 100 households.

#### Staff Transfer


